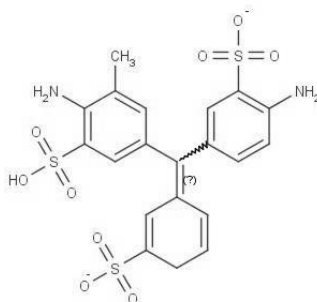

SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general

: Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Cardiac arrest: perform resuscitation. Victim conscious with laboured breathing: half-seated. Victim in shock: on his back with legs slightly raised. Vomiting: prevent asphyxia/aspiration pneumonia. Prevent cooling by covering the victim (no warming up). Keep watching the victim. Give psychological aid. Keep the victim calm, avoid physical strain. Depending on the victim's condition: doctor/hospital.

First-aid measures after inhalation

: Remove the victim into fresh air.

First-aid measures after skin contact

: Wash immediately with lots of water (15 minutes)/shower. Soap may be used.

First-aid measures after eye contact

: Rinse immediately with plenty of water for 15 minutes. Take victim to an ophthalmologist.

4.2. Most important symptoms and effects, both acute and delayed

5.1. Extinguishing media

7.1. Precautions for safe handling
